Release and Waiver of Liability

The undersigned vendor ("Vendor") has executed on the date set forth below, this Release and Waiver of Liability (this "Release") in favor of Polo on the Midway (POTM), Ladies Polo Auxillary, and Children's Advocacy Center for Denton County and their respective officers, directors, employees, and agents (collectively, "Owner") on the following terms:

This waiver shall be in effect on the Premises of Prestonwood Polo Club on October 30, 2010.

Vendor understands this waiver applies to all performances of services and work at Prestonwood Polo Club.

Vendor agrees to perform the Services in a good and workmanlike manner, using the utmost care and following all safety rules and precautions as may be reasonably applicable. Vendor does hereby expressly and specifically assume any and all risk associated with performance of the Services and Vendor's presence at Prestonwood Polo Club.

Vendor agrees to release and forever discharge Owner, its successors and assigns, from any and all liability, claims and demands of whatever kind and nature, either in law or in equity, on account of the negligence of Owner or otherwise, which arise or may hereafter arise from or in connection with the performance of the Services or Vendor's presence at Polo on the Midway. Vendor understands that this release discharges Owner from any liability or claim that Vendor may have against Owner with respect to any bodily injury, personal injury, illness, death, or property damage that may result from performance of the Services, whether caused by the negligence of Owner or otherwise.

Vendor acknowledges and agrees that Owner does not carry any health, medical, disability, worker's compensation or other insurance coverage for Vendor, nor does Owner assume any responsibility for or obligation to provide financial or other assistance to Vendor in the event of damage to property, personal or bodily injury or illness.

Vendor further hereby agrees to indemnify, defend and hold harmless Owner from any loss, liability, damage, or costs, including court costs and attorneys' fees, that may incur due to performance of the Services, whether caused by negligence of Owner or otherwise.

This Release is intended to be as broad as permitted by Texas law. If any clause or provision is held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.
